Dear Alarm Holder,

Alarm systems are a great tool for protecting your property. It is your responsibility to know how your alarm system operates to avoid false alarms. The Bolingbrook Police Department treats all alarms as true emergencies, that is why the Village of Bolingbrook changed the Municipal Code, Division 8, section 12-424(b) to fine excessive false alarms.

Alarm systems are required to be registered. Please return the form to the Bolingbrook Police Department if you have not done so.

Any alarm system, which generates more than three (3) false alarms in any twelve (12) month period (**ROLLING 12 MONTHS, NOT CALENDAR YEAR**) will be fined using the following rate structure”

1 st through 3 rd	no fine assessed
4 th through 6 th	\$75.00 per alarm
7 th through 10 th	\$250.00 per alarm
11 th through 19 th	\$300.00 per alarm
20 th and over	\$1,000.00 per alarm

Alarms resulting from the following conditions are not considered false alarms:

- (1) Criminal activity or unauthorized entry.
- (2) Earthquake causing structural damage to the protected premises.
- (3) High winds sufficient to activate motion detection system or causing physical damage to the protected premises.
- (4) Flooding of the protected premises due to overflow of natural drainage.
- (5) Lightning bolt causing physical damage to the protected premises.
- (6) Telephone line malfunction verified in writing to the village by at least a first-line telephone company supervisor.
- (7) Wireless radio transmission malfunction verified by the police or fire department.
- (8) Electrical service interruption verified in writing to the department by local power company.
- (9) Communication to the police or fire department before a unit is dispatched to investigate, clearly indicating that the alarm is resulting from authorized entry, authorized system test, or other non-criminal cause.
