# SPECIAL USE PERMIT FOR A DRIVE-THRU LANE/KIOSK. MEIJER, INC., 225 N. WEBER ROAD. APPLICANT: BRITNEY WURM, NEWCO DESIGN BUILD, LLC. PROJECT NO.: 402.18

Planning and Zoning Administrator, Matt Eastman, presented the request. The applicant is requesting a Special Use Permit for Drive-Thru Lane/Kiosk at 225 N. Weber Road. The property is approximately 22.85 acres, is currently zoned B-2 Community retail and is developed with a Meijer supercenter. Access to the subject site comes via multiple points off Boughton Road and Weber Road. The applicant is requesting to install a drive-thru pharmacy pick-up lane/kiosk along the northeast elevation of the existing building. Meijer feels this would offer a significant convenience to their pharmacy with relatively little impact on the existing site. Per the applicant, hours of operation would

coincide with that of the pharmacy, which is Monday through Friday from 9:00 a.m. to 9:00 p.m., Saturday 9:00 a.m. to 7:00 p.m. and Sunday 10:00 a.m. to 6:00 p.m. As a safety precaution to the customers entering or exiting the store, the applicant is proposing to install a 42-inch tall, galvanized steel fence on top of the sidewalk adjacent to the proposed drive-thru lane; thus, completely enclosing that section of the walkway from the parking lot and drive-thru lane.

#### RECOMMENDATION

Staff recommends approval of a Special Use Permit for a drive-thru lane/kiosk at Meijer, located at 225 N. Weber Road.
